 - o #736 Dry Branch Gerath, Stafford Twp., 1.06 acres Mr. Avery informed the Committee that this property is being donated to the Natural Lands Trust Fund. Mr. Palmieri noted that Stafford Township has already submitted a resolution of support for preservation of the property.

A **MOTION** was made by Mr. Mangum and seconded by Mr. Peterson to recommend acceptance of the donation to the Board of Commissioners. Roll was called, all in favor, motion carried.

- #734 Pine Lake Park Correia, Manchester Twp., 0.27 acres The Advisory Committee advised staff that this application will be heard at next month's meeting.
- ○#687 Country Lane Jones, Ocean Twp., 0.88 acres The Advisory Committee advised staff that this application will be heard at next month's meeting.
- o#715 LightHouse Drive Mickelsen, Ocean Twp., 0.13 acres Mr. Avery noted that this nomination was momentarily put aside to gather outreach

on surrounding lots. As of this time, two new nominations within the area have been submitted for review under the Natural Lands Trust Fund Program. The Advisory Committee advised staff to order appraisals on the property once township support has been received for all adjacent properties.

• New Applications:

- o #737 LightHouse Drive Souagui, Ocean Twp., 0.23 acres Mr. Palmieri informed the Committee that this property is directly adjacent to application #715. The asking price is \$30,000 and it is assessed at \$5,000. The Advisory Committee advised staff to obtain township approval for the property inclusion into the preservation program before moving forward.
- o #739 LightHouse Drive Patel, Ocean Twp., 2.89 acres Mr. Palmieri informed the Committee that this property is also in the LightHouse Drive acquisition area. The asking price is \$225,000 and it is assessed at \$116,100. The Advisory Committee advised staff to obtain township approval for the property inclusion into the preservation program before moving forward.
- o #742 Holgate Marsh, Long Beach Twp., 23 acres Mr. Palmieri informed the Committee that this property in Long Beach Township is 23 acres and has riparian grant rights included with the property. The property owner is currently working on getting an updated LOI from the State. Two surrounding neighbors of the property would like to see the property preserved and have agreed to contribute in the funding of the purchase. Long Beach Township also confirmed that they would contribute an amount depending on what the property appraises at. The asking price is \$10,000,000 and it is assessed at \$151,800. The Advisory Committee advised staff to order an appraisal on the property.
