## Ocean County Natural Lands Trust Fund Minutes of Advisory Committee Meeting July 24, 2024

- 3. Approval of Minutes: June 26, 2024

A **MOTION** was made by Mr. Fox and seconded by Ms. Hodgson to approve the June 26, 2024 meeting minutes. Mr. McKeon & Ms. Kuhn abstain, rest in favor, motion carried.

- 4. Program Update: 29,941.26 acres
  - Mr. Palmieri informed the Committee that there were no closings on properties for the month of July.
- 5. Old Business
  - Old Business:
    - o #734 Pine Lake Park Correia, Manchester Twp., 0.27 acres Mr. Palmieri informed the Committee that staff spoke to the Engineering Department regarding the ROW and whether or not they would have interest in purchasing the piece themselves. The ROW was 277.70' and Engineering was not interested in the property. The Advisory Committee did not see favor in purchasing the property due to the property being undevelopable from the presence of wetlands on the property. The Advisory Committee advised staff to gauge the property owners' interest on a donation or move the property to hold.
  - New Applications:
    - o #745 Jake's Branch Ext., Berkeley Twp., 28.62 acres Mr. Palmieri informed the Committee that the first new nomination is located in Berkeley Township off of Dover Road. The property is directly adjacent to State land as well as Ocean County's Jake's Branch Park. There is currently one structure located on the property. The asking price is \$7,000,000 and it is assessed at \$82,200. The Advisory Committee advised staff to conduct a site visit on the property.

- o #740 Clearview Street, Lacey Twp., 1.15 acres Mr. Palmieri informed the Committee that this nomination was submitted to us for consideration. It is a residentially zoned property available for single-family residential units buildable on the property. The property is not adjacent to any adjacent Ocean County Natural Lands preserves. The property owner is seeking \$56,500 and it is assessed at \$56,500. The Advisory Committee advised staff to forward the property to the US Fish & Wildlife.
- o #741 Lifetime Homes Mease, Borough of Ocean Gate, 0.31 acres Mr. Palmieri informed the Committee that this next nomination is directly adjacent to our Lifetime Homes preserve which is in the Good Luck Point Acquisition Area. The property is zoned Residential, however the property is mostly covered in wooded wetlands. The property owner is seeking \$348,200 and it is assessed at \$58,500. The Advisory Committee advised staff to gauge the property owner's interest on a donation or move the property to hold.
- o #396 Berkeley Island Park Ext., Berkeley Twp., 1.40 acres Mr. Palmieri informed the Committee that this former nomination was recently resubmitted to the program for consideration. It would be a beachfront extension to Ocean County's Berkeley Island Park. The asking price is \$1,700,000 and it is assessed at \$588,000. The Advisory Committee advised staff to conduct a site visit on the property.

#717 Hirsch, Jackson Twp., 0.65 acres – Mr. Hirsch (Public) addressed the
Committee regarding his nominated property which was formerly moved to hold
back in March of 2024. Mr. Hirsch supplied the Committee with copies of
information regarding his property and why he believes that they are important to
preserve under the Ocean County Natural Lands Trust Fund. The Advisory
Committee thanked Mr. Hirsch for his time, and will discuss this property further
and reach out with their decision at a future date.

A **MOTION** was made by Mr. Mangum and seconded by Mr. Fox to move into Closed Session at 6:07 p.m. All in favor, motion carried.
