Proof of Mailing, Notice of Application & Renunciation for Administration Directions

• When consent forms or renunciations of Administration forms need to be signed by next of kin and they are refusing to do so, the person who is wanting to be the acting party will need to **notice them in order to move forward**. If the process would have been an affidavit of next of kin but there are parties who are not willing to sign, the process must become an administration.

• The Person Seeking Appointment Will Mail:

- Proof of Mailing
- Notice of Application for Letters of Administration
- Renunciation of Administration

• Prepare Three (3) Sets of The Above Forms:

- One set will be sent regular mail
- One set will be sent certified mail, return receipt requested (green card)
- One set will be kept by the person seeking to be appointed

• When to come into our office to make application:

Once the green card comes back signed **OR** the envelope from the certified mailing comes back unopened, unsigned for "<u>return to sender</u>" (**DO NOT OPEN THIS ENVELOPE**). We will need either the green card or the unopened envelope to be brought into the office for proof that this person was noticed... along with the copy that you kept for yourself.

Just remember, there is a **10 day in state** and **60 day out of state** rule for the person you are noticing. Be sure to make the date of application with this in mind.

You cannot come into the office on the date you wrote on the notice if you have not received the green card back or if you have not gotten the envelope back unopened. You will need to wait for either one of these things.
