The Office of Senior Services was established by the Ocean County Board of Chosen Freeholders in 1973 to serve as the county Area Agency on Aging. (AAA). Since its inception, the AAA has been responsible for planning, administering and monitoring a comprehensive and coordinated system of home and community-based services using federal funds under the Older Americans Act. Working with non-profits, social service agencies, and local and state government, the AAA has cultivated partnerships and developed programs to provide essential services to the nearly 200,000 older adults who call Ocean County home. In 2012, Ocean County joined the state in its ADRC initiative to implement "No Wrong Door" creating a single point of entry for older adults and adults with disabilities to access information on home and community-based services.

The AAA conducts a comprehensive needs assessment of older adults through oral testimony provided at our annual public hearing, on-line and paper surveys as well as input from community stakeholders. The most recent needs assessment was conducted in May 2024 and will inform the planning process for our 2025 – 2027 Area Plan Contract along with the priorities set by the State Unit on Aging. The results clearly demonstrate that a significant portion of older adults in Ocean County are struggling with transportation, financial security, food and housing instability as well as affordable home & personal care assistance.

2024 Department Highlights

Medicare

The Office of Senior Services administers the State Health Insurance Assistance Program (SHIP) Through the SHIP program, our certified counselors provide local, unbiased Medicare counseling and enrollment assistance to eligible beneficiaries in Ocean County. This program provides one-on-one counseling as well as education and outreach events to assist residents navigate the Medicare system as well as help them understand and compare plan options. The Office of Senior Services had a busy year with over 6,895 contacts.

Evidence based programs

The AAA has expanded our offerings to include two new evidence-based programs designed to support healthy aging and empower older adults. The Wellness Recovery Action Plan (WRAP) is now available for individuals aged 60 and older, focusing on helping participants make informed choices to enhance their wellness, quality of life, and physical health. This program covers essential topics such as discovering personal strengths, developing a wellness toolbox for healthier and happier aging, fostering hope, strengthening social networks, and taking charge of one's wellness. Additionally, we have introduced the Wellness Initiative for Senior Education (WISE) program, which aims to educate older adults about the facts and myths of aging. WISE provides participants with greater insight into their own feelings about aging and heightens awareness of the advantages that come with growing older. Both programs are evidence-based, ensuring that participants receive effective, scientifically-supported interventions to support their well-being and promote successful aging.

Mobile Unit Ribbon Cutting

The AAA has taken several steps to implement "No Wrong Door" and to increase outreach to our senior population. The AAA increased its footprint in the county and now has 3 separate office locations including our main office in Toms River, the county seat, a satellite office at the County Connection conveniently located in the Ocean County Mall and our newest location in the Ocean County Southern Service Center in Manahawkin. Our Manahawkin site allows us to better serve the growing senior population in the southern part of the county. We are also pleased to announce the official kick off of our mobile unit, a fully functioning office, that will allow us to bring information and assistance directly to older adults and individuals with disabilities.


Caregiving

The AAA/ADRC has a highly experienced JACC Care Coordinator who is also a registered nurse, and the Project Director assigned to administer and oversee our Caregiver Information & Assistance services. Under Care Coordination, the JACC application and eligibility process is managed closely to relieve as much caregiver burden as possible by assigning dedicated staff, providing home visits, assisting with documentation, completing thorough Screens for Community Services and advocating for applicants and participants when necessary. For the year 2024, 232 Screens for Community Services (SCS) have been processed for JACC and Managed Long-Term Services and Supports (MLTSS). Our Care Coordinator has extensive prior Care Management experience and conducts presentations throughout the year sharing her firsthand knowledge with providers, stakeholders, and residents. Caregiver Volunteers of Central Jersey (CVCJ) provide caregiver relief, and respite. They have an Alzheimer's Respite Care Program that eases the burden and enhances the quality of life for the primary family caregiver of a loved one with Alzheimer's disease or any type of dementia. Self-help groups offered through our provider network include caregiver support groups, Care2Cargivers for dementia caregivers, bereavement support groups, grandparent supports and mental health counseling.
