ADVANCED VEHICLE EXTRICATION

This course is divided into 2 sessions. Each session is hands-on in nature with some lecture. This is designed for experienced firefighters or first aid members in the extrication field. This may also serve as a refresher for those experienced personnel. Specific topics to be covered include: rescue & victim safety, vehicle dynamics and terminology, tool selection and use (hydraulic, electric, hand and pneumatic), basic stabilization techniques and vehicle displacement.

ANIMAL EMERGENCIES FOR THE FIRST RESPONDER

Give it enough time and we will all run a call where an animal will be involved. Whether it be a structure fire, MVA, a unique rescue situation, or yes, even a cat in a tree, we need to be prepared to care for our fuzzy and/or 4 legged friends. This course will outline common and uncommon emergencies that may involve an animal. This course is open to EMS personnel.

CANDIDATE PHYSICAL AGILITY TEST - PREP COURSE

Commencing in 2025, recruits for the basic firefighter 1 & 2 course will be required to complete a Candidate Physical Abilities Test (CPAT) before acceptance into the program. This test will consist of a sequence of events and tasks performed in a continuous manner to evaluate a candidate's ability to perform essential tasks at a fire scene. It will be a timed, pass/fail test based on successful completion of rigorous tasks while wearing a weighted vest.

This prep course will allow prospective recruits to prepare for entrance testing by receiving a practice test of what will be expected of them. Participants will get a "dry run" in an effort to set them up for success come test day.

DRILL GROUND INSTRUCTOR

This New Jersey Division of Fire Safety course is designed to ensure that Fire Service Instructors know and understand the safety issues inherent in each of the subject areas of firefighter training, Instructors must be capable of demonstrating the proper methods of identifying and correcting an unsafe situation as it occurs. Instructors must also demonstrate a knowledge of equipment and apparatus maintenance and safety procedures since well-maintained equipment is necessary to do the job safely and effectively. This program is required for fire service instructors who wish to teach specified modules in the Firefighter 1 & 2 courses in the State of New Jersey. It is also a good program for company officers who plan on conducting FD drills to attend. This course will provide the student with a basic understanding of live burn and SCBA safety concerns.

FIRE GROUND SURVIVAL

Statistically if a firefighter calls a MAYDAY it is within the first 15 minutes on scene. Is RIT established? Are they still responding? Who's coming to save you? The reality is, as long as you can move, it's up to YOU! This course will go over different MAYDAY emergencies firefighters may encounter and how to rescue themselves. Students will be pushed to their physical and mental limits, and then they will have to call a MAYDAY and fight to get out. This is a physically intensive course. PPE and SCBA are required for both sessions.

FIRE INSTRUCTOR LEVEL 1

This class is required by the New Jersey Division of Fire Safety for firefighters who wish to be certified as Level 1 fire service instructors. The class is also recommended for new or up and coming officers.

FIRE OFFICER 2

This course is designed for the certified Fire Officer I, who wishes to remain versed in essential and innovative management, leadership and human relations methods while examining critical issues in leadership, human resources, instructing, community interaction, and finances. The course curriculum corresponds to the requirements as set forth in N.F.P.A. 1021 (Professional Qualifications) for Level II in personnel and fire ground management. Upon completion, students will have a better understanding of the following topics: managing personnel, community and governmental relationships, administration, inspection and investigation, NIMS, and public speaking.

PREREQUISITE: FIRE OFFICER I

FIRE POLICE

This course will provide the basic knowledge & skill for all newly assigned Fire Police Officers, as well as those experienced firefighters involved with traffic and crowd control at an incident scene. This program meets the New Jersey Statute 15:8-4 concerning the training of Fire Police Officers. Topics covered are: history, demeanor, personal protective gear, Red & Blue light laws, scene size-up, workplace safety. The class includes indoor classroom instruction blocks and an outdoor-practical evaluation.

In accordance with NJ Highway Incident Traffic Guidelines for the First Responder, each student is required to bring a Class II safety vest to the outdoor practical class.

PREREQUISITE: IS 100, IS 700, IS800, ICS 200 and NJTIM

FIREFIGHTER DOWN!

A revision of Firefighter CPR, this course will outline the causes of firefighter related cardiac events and how to quickly begin CPR on a downed firefighter in full turnout gear with SCBA. Rapid removal of PPE is imperative in order to transfer care of the firefighter to EMS. In addition, this course will present suggested practices during and after a firefighter down situation. With a national average of approximately 100 firefighters who die in the line of duty annually, many of them from cardiac events, early CPR and properly established practices are our best hope to save a life!

FIREFIGHTER LEVEL II

This course is designed to meet the requirements of NFPA 1001, Professional Qualifications for Firefighters and the New Jersey Division of Fire Safety Firefighter II certification regulations. This course shall provide the student with the knowledge and skill to operate at an emergency scene with minimal supervision. This course includes lessons in advanced structural fire attack, flammable liquids and gases firefighting, foam operations, working with technical teams, fire origin and cause awareness, motor vehicle extrication, firefighter survival (RIT), and Incident Management System.

PREREQUISITES: Firefighter I certification; IMS 200 and CPR/AED Certification.

HAZ-MAT: INCIDENT COMMANDER

This course meets the training requirements in OSHA 29 CFR 1910.120 and NFPA 472 for incident commanders at a hazardous materials incident. Through the application of the incident command system, this course will provide emergency responders with operations and management responsibilities the tools to effectively manage emergency incidents

PREREQUISITE: Haz Mat Awareness & Operations, Incident Management Level 2

INCIDENT SAFETY OFFICER

The Incident Safety Officer course is a National Fire Academy certification that will certify each participant as meeting the NFPA 1521 Standard for Incident Safety Officer. This course is both lecture and hands-on with tabletop exercises.

Participants will cover the following sections: The role of the Incident Safety Officer, Policies, Procedures and guidelines, Record keeping and Documentation, Risk management, and Incident considerations.

ICS - 200

Basic ICS – Basic Incident Command System for Initial Response. This course is designed to enable personnel to operate efficiently during an incident or event within the Incident Command System (ICS). This course focuses on the management of single resources. I-200 provides training on and resources for personnel who are likely to assume a supervisory position within the ICS.

PREREQUISITE: CERTIFIED FIREFIGHTER I, EMT, POLICE OFFICER, or OTHER FIRST RESPONDER

ICS - 300

Intermediate ICS for Expanding Incidents for Operational First Responders. This course provides training on and resources for personnel who require advanced application of the Incident Command System. The target audience for this course includes individuals who are expected to perform in a supervisory or tactical level management role at an incident or event. This includes individuals who may serve as Division / Group Supervisors, Branch Directors, Resource Team or Task Force Leaders, Unit Leaders, or multi-agency coordination system/emergency operations center (EOC) staff. PREREQUISITE: ICS-200

READING SMOKE FOR THE INITIAL SIZE UP

This course explores the characteristics of smoke volume, velocity, density, and color to identify cues necessary to developing a safe, strategic fire ground incident action plan. These observations made during the initial size-up will assist the fire ground incident commander in being proactive in determining the mode of operation while keeping in mind the survivability of the interior and the three incident priorities of Life Safety, Incident Stabilization and Property Conservation. Using these lessons learned students will explore various fire attack options including the establishment of a traditional Offensive/Defensive attack as well as exploring transitional options. Concepts are delivered through an interactive PPT/Video, lecture/discussion.

STOP THE BLEED

The #1 cause of death after an injury is bleeding. With an increase of violent situations that are occurring, it is imperative to be trained on how to stop bleeding as rapidly as possible. This course will show actual incidents where the Fire Department was on location and could render aid. The hands-on portion will have students applying tourniquets and packing wounds to help save a life!

No prior first aid experience is necessary. This course is open to EMS and Police personnel.

EMT's will receive 2 CEU's

V.E.S. (Vent, Enter, Search)

Vent, Enter, Search (VES) is a time-tested proven rescue technique that aims to provide rapid rescues through deliberately targeted search areas. Thus, increasing survivability of our victims. We will cover V.E.S. and ladder tactics, history and the aggressive search and rescue mindset. Then, practical training, where under live fire conditions, you will execute these ground ladder tactics, including unconscious victim removal from upper floors, one person ladder throws (25 & 35 foot), rapid masking up procedures and more!!!

The instructors aim to make this class as REAL as possible and utilize some extremely experienced instructors who provide real life experience in what works and gives your victims the best chance of survival.
