COMMISSIONER BACCHIONE: "Thank you. Good afternoon, everyone. It is my privilege to be sworn in today as a commissioner to represent all the residents in Ocean County to the best of my ability. I. COMMENTS FROM THE DEPUTY DIRECTOR

DEPUTY DIRECTOR SADEGHI: "Thank you very much. Jack Kelly, obviously wanted to be here, was planning on being here, but as you know the southern part of Ocean County has a lot more snow than we got up here, and Jack Kelly kind of lives in the woods in Eagleswood. (laughter) I think it takes like 45 minutes to get from the street to his house. The drive is two miles long, so I think he's still out there shoveling snow. I wanted to see if Commissioner Haines had any comments."

J. COMMENTS FROM THE MEMBERS OF THE BOARD OF COMMISSIONERS

COMMISSIONER HAINES: "Oh yes, I would. Thank you. Good afternoon. I just want to welcome our new Commissioners, Jennifier Bacchione and Rob Arace to the Board. It is truly a privilege to serve for the residents of Ocean County. I look forward to working with you both as we continue to make Ocean County the best place to work

and retire. I want to congratulate Commissioner Kelly on being named the Board's Director for 2025 and Commissioner Frank Sadeghi for being named the Board's Deputy Director. I am sure both of you will do a fine job in these roles.

In looking back in 2024 the Board of Commissioners did great things for our residents. I'm especially proud of the work done in the Ocean County Department of Parks and Recreation as we created numerous all-inclusive park playgrounds so all of our children at all levels of development can enjoy recreational activities close to home. We also received our Pinelands Commission permit in order to move ahead with a new Regional Park in Manchester Township, finally. It took quite a long time to get that. We all look forward to the day when we can open this site to the public. I am happy to note that we also expanded the availability of pickleball courts to meet the growing interest in the sport. We also did great things with open space last year making certain we continue to preserve and protect our environment by purchasing open space that meets the criteria for the Ocean County Natural Lands Trust Fund. The program has a significant role in our environmental stewardship in the county and the quality of life in Ocean County.

While the list of the Board's accomplishments are long I want to extend my appreciation to all the Department Heads and employees who diligently implement our programs and services. We sit up here. We make the decisions, and we vote, but it's really them who do the work and we just get all the accolades for all the great stuff that's being done in Ocean County. I look forward to continuing to work with all of you in the new year as we move forward and doing great things for our citizens. With that, I want to wish you all a Happy and Healthy New Year and thank you for joining us today. God bless the United States of America. And, please, God bless our men and women serving in our United States Military. Thank you."

DEPUTY DIRECTOR SADEGHI: "Thank you, Commissioner Haines. I just have a couple of words myself. First, I want to thank everyone for coming out and being here and participating in these proceedings. It's good to see friends, family members. We can always count on, once a year, seeing everybody here and it's a good thing. I want to congratulate Rob Arace and Jennifier Bacchione in their election to the Commissioner's Board and wish them luck in advancing the issues that face our residents. It's a difficult job. It's a difficult position. And some of us, I don't know what it is, that this does, running for office...I see a lot of officeholders in the audience. I think Senator Singer has been doing this for over 100 years. (laughter) And I don't know what it is, what aspect of our soul gets fulfilled with this but it's not an easy thing because no matter what decision you make, you're going to accommodate certain people and make certain people happy and make some people not so happy.

I want to thank all the Freeholders that have served the residents of Ocean County in the past. We saw Joe Buckelew who was a Freeholder back in 1972 to 1975, but those are the people, the officeholders that put the foundation in place, and that foundation is a sound foundation. The rest of it is not as difficult. You just have to lay the blocks and make sure that we don't go astray and build on that foundation.

Joe Vicari, I talked to him over the weekend. He wanted to be here, but I think he's heading south for the sunshine, but he wanted me to say that he's wishing everyone a Happy and Prosperous 2025. I want to thank Jim Lacey, Gerry Little and Jack Kelly for having been here for 33 years. Again, it's not a difficult thing. It's not an easy thing. The credit for good government also goes, predominately to the county employees. They're the ones, as Commissioner Haines indicated, that make us look good on a daily basis. They're out there plowing the snow, fixing the roads, educating our kids. I see the Ocean County College President is in the audience. Thank you, Dr. (Pamela) Monaco, for everything that you and your staff does. They maintain our parks, not Dr. Monaco, (laughter) and provide our seniors and veterans with the services they need every single day. We pledge our fierce commitment to our law enforcement community. We talk about the quality of life. A lot of us were attracted to Ocean County. I wasn't born and raised here. I think Commissioner Haines was. She was one of the lucky ones. But we came here back in the early 90's because...and I wanted to raise my family here because of the quality of life. You have the pristine beaches and the boardwalks and those charming downtowns and that's what attracted us, most of us to this county. But without the support of the law enforcement community...I don't know if the Sheriff is still in the audience. He's out here for everything. The Sheriff is 24/7. I don't think he sleeps. He'll call you at 3 o'clock in the morning, 'There was an accident on Route 70. Do you want to go?' And I'm like, 'You woke me up for this?' (laughter) But he's 24/7. We're lucky to have him and thank you. Thank you, all the sheriff's officers, police officers, for everything that you do to keep us safe and allowing us to enjoy those quality-of-life things that we enjoy in Ocean County.

Our mission for 2025 is to continue to build upon what we started last year. I really believe that Ocean County Vocational Schools, can be, and will be, the premier vocational training in the entire country. We started that initiative and some of that was started under the leadership of Commissioner Haines, and prior to that, Commissioner Vicari, renovations to the existing facilities at Ocean County College. Again, I can't thank President Monaco for being more supportive and forthcoming with making the facilities...I don't know if Jerry Dasti is here. He's the Chairman of the Board of Trustees at Ocean County College. We've had very productive meetings, brought the two sides together. They're communicating. They go over each other's houses now on weekends and have barbecues. They don't invite us but that's okay. We started a pre-nursing program. We're renovating some space at Ocean County College, and we were able to accommodate kids, students. I call everybody kids, in September of this year. The plans for the expansion of the MATES (Marine Academy of Technology and Environmental Science) School and I can't say enough about our County Architect, Massimo Yezzi, who's again, 24/7. I don't know...Mass, do you have any plans to retire at any point? Yeah, he's got the same mode that I'm in, you know, work until you die. But he's been diligently working on the plans for the expansion of the MATES School and that is going to be up in

operation, I believe, by September of 2026. The addition to the Jackson Training Center started this year and the completion will house the students as soon as this September, I believe. We're making good progress out there.

We plan to assist the Vo-Tech Schools to expand the Academy of Law and Public Safety, the ALPS program, for students pursuing careers in law enforcement, homeland security and public safety. We will assist the Vocational Schools. I know I'm committed. Commissioner Haines has been doing this. I know Rob Arace is very passionate about it and so is Jennifier Bacchione. New programs, innovative things that draws kids like artificial intelligence (AI), robotics. I wanted to say drones but let me qualify, (laughter) drones...yes, I got to be careful. Drone's sciences but also drones manufacturing and engineering programs.

Switching gears, JCP&L...I know we've had outages again in Lakewood Township, Manchester Township. It's unacceptable. We are being treated like stepchildren and I don't understand what that is. I think we've put JCP&L on notice that if they don't want this franchise, if they cannot accommodate this franchise and the people of Ocean County, we're going to hold them accountable. We're going to hold them accountable and responsible for all of the blackouts, all the power interruptions in all the municipalities that's under their franchise in Ocean County. JCP&L's incompetence and disruption to their... it is remarkable damage. It causes remarkable damage to the economic growth. We are so lucky today that we live in Ocean County because the economy of Ocean County...I look at the valuations of all the counties. The State of New Jersey publishes that information on a yearly basis. If you look at it, Bergen County, for all intents and purposes, is a suburb of New York City. The valuation of properties is much higher up there. Monmouth County is second and Ocean County is third now. And I think in 20 years when we reach that million people threshold, we're going to be number one. I am convinced of that. And JCP&L by interrupting this economic growth...I actually brought this up at the last meeting and probably at a couple of meetings before that, I really believe that the rest of the commissioners should join me. We have to get JCP&L's attention. Up to this point they reset up meetings. We talk about things, and nothing happens. I say that we immediately file a suit against JCP&L in the amount of \$1 billion. Now, Lauren Plump who's my checker, fact checker, says, 'Where did you come up with \$1 billion?' And some of it is quantifiable – the taxes that we can realize, the ratables that we can realize from all these office buildings that are sitting out there. They cannot complete these office buildings. If you've seen it in the vicinity of the growth up there is incredible in the vicinity of the ballpark in Lakewood. These buildings are...and there's probably another dozen buildings that are in the planning stages. JCP&L is telling them and these developers that we don't have power for you. At which point did they realize, or didn't realize, that Lakewood was in a huge growth pattern. That was pretty evident. I've talked to them about this. I don't know if it's...the incompetence comes from the fact that we don't have other options. You cannot just turn to PSE&G and say going forward I want you to be the power provider for me. But at this point I think we've had enough talks and enough nice meetings. I think we have to take action and that is going to be what I recommend to the rest of the commissioners.

One of the things that we're going to continue is we had meetings set up before the summer with the various towns, talked to the mayors and council people and administrators and stockholders in many towns and it was good. It was good to hear their issues, their grievances, their accolades about the county government, but it was also good to have, to create the forum where we could have them talk to one another. And we're going to continue to do that. Transparency and accountability in government...we started talking about implementing some ethic reform and that comes with...it's simple stuff. Who uses the vehicles. What's the circumstances. Who approves them. We talked about travel policy. We need to make sure that those programs are robust and protect the taxpayer and the taxpayers' money.

I could go on and on, but I want to save some of my remarks for the next meeting. So, at this point I'll turn the meeting back over to the Clerk of the Board."

O. INTRODUCTION OF DIGNITARIES

CLERK GUNTHER: "That concludes the business portion of the meeting. Deputy Director."

DEPUTY DIRECTOR SADEGHI: "Do we have the list of...? Why do I get to do this?" (laughter)

COMMISSIONER HAINES: "You're the Deputy Director."

DEPUTY DIRECTOR SADEGHI: "I just want to point out that there are some dignitaries in the attendance. We appreciate you being here. It shows that you're supporting this Board of Commissioners.

Avi Schnall, Assemblyman from the 30th District is here. 9th District Senator, Carmen Amato is here. He's part of the family. 9th District Assemblyman, Brian Rumpf is here. Good to see you, Brian. 9th District Assemblyman, Greg Myhre is here. Good to see you, Greg.

George Gilmore...I can't say enough about George. Talk about people who are 24/7. This man doesn't sleep. I don't know what kind of diet he and the Sheriff are on, but I want to be on that diet because I could be a lot more productive. Thank you so much George for coming out and supporting us, always.

Jeff Sagnip, Representative, not from Andy Kim's office but Congressman Chris Smith, although I'm going to put in a good word for you with Andy Kim. (laughter)

Our good Senator from the 30th District, Bob Singer. What can I say about...Bob, you want to say a couple of words?"

SENATOR ROBERT SINGER: "Never ask a Senator to say a few words. (laughter) That's a big mistake. First of all, I just want to clarify one thing. I was not sitting in the first row, but Lauren (Plump) switched the Clergy sign. (laughter) Insisted I sit in the front with her. So, you're forgiven, Lauren. First of all, congratulations to Deputy Commissioner Sadeghi. I'm privileged to be part of that group you put together with our terrific President of the College, the Superintendent of the Vocational School, yourself, Ginny Haines, George Gilmore, members of the unions, that talk about how we can prepare our young people for jobs in the future, how we can encourage new programs for the College and Vocational School together. We meet once a month. It's produced some wonderful things. As you know we're putting a new school of hygienists in there because of that. Over a \$3 million commitment you've made with the college. It's exciting, something new, something different. I appreciate you and Commissioner Haines for moving forward on these issues and understanding the future of our children.

I'm absolutely thrilled that Jennifier Bacchione was elected. She's a dear friend. I have a close relationship with her husband, John, who's a mayor. And as she knows, and of course as Mayor Arace would know in the future, mayors have a bonding together. We understand and to me that's the hardest job there is in the world, being a mayor. They're the ones they call when the streetlights don't go on or the fire engines don't come fast enough. The police don't arrive. The ambulance doesn't come, and the streets aren't plowed.

So, again, I want to thank Commissioner Arace on his great job, his friendship. We like martinis together, thank you. And the fact is that Jennifier is always there and willing to help and add her advice.

Lastly, I want to say one thing. I'm here with Deputy Mayor Menashe Miller from Lakewood. We appreciate very, very much your comments about JCP&L. We have approximately 8 to 10 buildings that have been approved that we cannot build because there's no power. Not about the power going out. We're talking about no power and that is jobs, revenues for Lakewood Township, revenues for Ocean County, revenues for the State of New Jersey. I'm urging you to move forward in anything we can help you with as far as Lakewood is concerned as the economic engine of the state of Ocean County to help us in this plea. We have had the President of the Board of Public Utilities down. She understands the issue. Maybe because JCP&L is not based in New Jersey. It's based out of state. It's the reason why we desperately need your help. Two to six years is not acceptable. We need help now. And that goes along with a lot of things including the Route 9 corridor including other issues based in Lakewood Township. It is the fourth largest town in the State of New Jersey. It's over 150,000 people and growing. We desperately need help and guidance in that direction from you as the commissioners and I'm very glad to see that Deputy Commissioner Sadeghi makes that a major issue. So, on behalf of my district and the only town that myself, Avi (Schnall) and Sean Kean represent in Ocean County is Lakewood being the largest. We are very, very happy to see that you're committed to help us and we appreciate it greatly. I wish all of you the best health. Commissioner Haines and I go back a long time together. We worked together when I first was in the assembly. I worked with her when she was the Lottery Commissioner and then came on the assembly, of course as a commissioner and freeholder. So, I thank you all for your fine work and we appreciate the great job you do. Thank you."

DEPUTY DIRECTOR SADEGHI: "Thank you, Senator."

At 4:20 PM, Deputy Director Sadeghi received the following comments from members of the public:

DEPUTY DIRECTOR SADEGHI: "Now, comments from the audience. Anybody who has anything to say. Only positive things today. This is our "reorg" (laughter) If you have anything bad you want to say, you know, hold it for next meeting."

GEORGE GILMORE, 15 CRANMOOR DRIVE, TOMS RIVER: "I just want to congratulate Rob and Jen. They ran a tremendous campaign. You can't do it by yourself. You have to do it with the support of your family and friends and they won by over 200...they won...I think you each got 217 and 210. You won by more than 100,000. Alright, we're going to have a recount, Rob, so we'll get it closer together. (laughter) But congratulations. Do a great job."

DEPUTY DIRECTOR SADEGHI: "Thank you."

(Applause)

BILL SPADEA: "I'm Bill Spadea. Many of you know me from New Jersey 101.5 and I can tell you two things. Number one, as long as I have a mike, I cannot wait to talk about this JCP&L lawsuit. Go get him. It is absolutely outrageous. Congratulations, Rob. Congratulations Jennifier. You guys are joining an incredible Board from Commissioner Kelly to Deputy Director Sadeghi, to Commissioner Haines. This is such an outstanding Board, and I say this even though I am in Mercer County I've got the largest audience in the state, and I've been listening to people from Ocean County for ten years now, and every time I ask the question, are you digging in with me to stay in Jersey it is an overwhelming positive from Ocean County. And that is in no small part due to the incredible job that these commissioners have done over the years keeping taxes under control, making sure infrastructure works. And it's been said...Senator Singer talked about it; how hard it is to be a mayor. Well, it's equally hard to be a commissioner and know that you are the catch-all for things that happened in the county, and I can tell you that for the commissioners who have been serving this county faithfully you've got two great additions who are going to help keep this county as great as it has been. So, Happy New Year. Congratulations to all of you."

DEPUTY DIRECTOR SADEGHI: "Thank you, Bill." (applause) Anyone else? Yes, sir."

GARY BLACK: "Hello. For the new kids on the block, I used to be a regular. That's something I'm going to be calling you guys is the new kids on the block. I used to come up to almost every meeting. I've had some personal issues and some medical issues that kept me away."

DEPUTY DIRECTOR SADEGHI: "What is your name, again?"

GARY BLACK: "Oh, Gary Black. That's right. I'm not used to you guys not knowing it. Okay, I'm an advocate for the Natural Lands Trust. I speak highly about that. Not only does it do a lot for the environment it also pays for itself because ratable growth is one thing, but you also got to think about especially when it comes to residential housing. With ratable growth comes expenses which sometimes over due the ratable growth you might get especially with our education taxes and now with New Jersey violating the New Jersey Constitution and not honoring its responsibility in paying for education. I don't know if you guys know or not, we're not a state constitution. The only thing we're supposed to be paying for is transportation extracurriculars. The state is supposed to be responsible for everything

else. That's why during a lot of Democratic administrations it's almost impossible to get a copy of the State Constitution. I've noticed that.

I would also like to say hello to our next governor. (looks over to Bill Spadea) (laughter) By the way, and I've always been one that a lot of people called me a lightning rod. I always speak what I want to say. I'm an active Republican for those of you who don't know. This is weird. I'm not used to facing new people up here. So, it's hard for me to. But now I'm no longer a government worker. I actually...I'm no longer on the Ocean County Committee and so I can say whatever the hell I want now. And I'm retired. So, it's party time. I grew up in Ocean County. By the way, I'm a native. I'm used to the Board doing this already but...yes. I remember Route 37 being a two-lane concrete highway with one bridge going over. That's how far back I go. I remember in Lacey Township when we moved from Lacey to Toms River there was only one streetlight, one traffic light and that was on the corner of Lacey Road and Route 9 where Hebrew's Bar used to be. So, I know the history.

Going back, real quick, for the Natural Lands Trust, for every land that's preserved we don't have to provide services for it. So, by not providing those services, that pays for what we pay for the land. So, not only is it an economical benefit it's a financial benefit for our county too. I'm not a biggy on growth. I grew up during the 60's with the whole ratable chase nonsense. But everybody forgot with ratables comes expenses. Commercial ratables is a good bang for the buck. Industrials even better. Residential is almost a negative, so, just think these things through. I know your predecessors had that down. They understood because they saw it in their own townships, and they dealt with it."

DEPUTY DIRECTOR SADEGHI: "Alright, Gary. Everybody is getting antsy because we're going to have a party. There's going to be food. They want to eat."

GARY BLACK: "Alright. I'll be seeing you there. Alright. I'm sorry. I was about to close."

DEPUTY DIRECTOR SADEGHI: "Come back to the next meeting."

GARY BLACK: "Alright. And good meeting."

(Applause)

DEPUTY DIRECTOR SADEGHI: "Thank you. Anyone else?"

SHAWN DENNING, 92 MOREY PLACE, WARETOWN: "I'm the President of the Ocean County Young Republicans and I just wanted to say congratulations to Jen and Rob. It makes us, as the President of the Young Republicans so proud to see a young Republican up on the dais here. We look forward to working with you guys, and helping you any way that we can, and all the success that this year brings. So, congratulations again, guys. Thank you so much."

DEPUTY DIRECTOR SADEGHI: "Thank you."

COMMISSIONER BACCHIONE: "I just wanted to mention, also in attendance... because it's so packed in here, the Mayor of Barnegat, and pretty much all of the Council is here too, so thank you guys for coming."

DEPUTY DIRECTOR SADEGHI: "Barnegat is in the house. Anyone else? Mark Jehnke, nothing? He's the County Engineer, by the way. If you have any issues with your roads or whatever, you want to see him. We'll announce his cell phone number later. (laughter)

INTRODUCTION

The New Jersey "Local Fiscal Affairs Law", specifically N.J.S.A. 40A:5-14, as amended by P.L. 1997, c.148 on June 30, 1997, requires that every local unit shall adopt a "Cash Management Plan." This plan lists the GUDPA approved depository banks, any broker/dealers, and the approved investment instruments selected by the local unit's governing body.

In addition, the cash management plan is to be adopted by resolution, usually at the reorganization meeting, or the first meeting of the year and will guide the investment of a local unit's idle cash during periods that it is not needed to meet obligations.

The County of Ocean has a formal Cash Management Plan which was initially adopted on July 6, 1983 and revised on February 4, 1998.

The purpose of the current revision is to modify the procedures currently followed under the current Cash Management Plan to comply with the provisions of P.L. 1997, c.148 as enacted on June 30, 1997.

This new act revises and expands the responsibility of the governing body and the role of the Chief Financial Officer in cash management as well as expanding the range of the allowed investment vehicles used by a local unit to invest its idle cash.

GENERAL AUTHORITY

The Board of Commissioners for the County of Ocean authorizes the Chief Financial Officer of the County of Ocean to administer the Cash Management Plan in order to deposit and invest the County of Ocean's idle cash pursuant to the stipulations contained in the Cash Management Plan.

ELIGIBLE DEPOSITORIES FOR PUBLIC FUND

Eligible depositories for County funds are New Jersey banks or savings and loans specifically approved by the New Jersey Department of Banking and Insurance under the Government Unit Depository Protection Act (GUDPA) and maintain a banking presence in the County of Ocean. Deposits of County funds in institutions other than those covered by GUDPA are prohibited by law.

As part of the County's Cash Management Plan, annually The Board of Commissioners shall adopt a list of the approved depositories for the County (ATTACHMENT A).

RFP – Request for Proposal

While P.L. 1997, c.148 formally exempts banking services and investment purchases from the bidding provisions of the Local Public Contracts Law N.J.S.A. 40A:11, all investment and banking services for the County of Ocean may be selected through a Request For Proposal (RFP) process.

When the need for banking and investment services exists, the County Chief Financial Officer may solicit RFP's from the eligible banking and investment institutions.

Upon receipt of the RFP's, the County Chief Financial Officer will then review each proposal. After the review, the County Chief Financial Officer will make recommendations to the Board of Commissioners. If necessary, the County Auditor may be asked to aid in the review process.

Once an investment or banking institution has been selected, the County's Cash Management Plan will be revised and adopted by resolution by the Board of Commissioners for the County of Ocean.

III. CASH MANAGEMENT POLICY

It shall be the policy of the Board of Commissioners for the County of Ocean to adopt the Cash Management Plan by resolution at the annual reorganization meeting or during the year as deemed necessary to reflect changes in laws, depositories, investments or funds.

The Chief Financial Officer for the County of Ocean is directed to invest and deposit funds pursuant to the cash management plan as adopted by resolution of The Board of Commissioners of the County of Ocean.

It is the objective of the Cash Management Policy to maximize the investment and interest income earned on idle County funds while providing adequate liquidity to meet the obligations of the County.

Timely Deposit of all County Funds:

As required by N.J.S.A. 40A:5-15, all monies collected or received from any source by or on behalf of the County or any board or Department thereof shall be paid to the "Treasurer, County of Ocean", who shall deposit all such funds within 48 hours after receipt, to the credit of the County of Ocean in one of the designated legal depositories.

All deposits forwarded to the Chief Financial Officer of the County of Ocean shall be accompanied by a revenue transmittal form listing cash and individual checks and will include a revenue account to which funds will be credited upon deposit.

Deposits to Interest Bearing Accounts:

It is the explicit policy of the County of Ocean that all funds be deposited into interest bearing accounts except as noted below.

All Departments and/or agencies of the County who collect monies for the County in the normal course of its activities must deposit said monies in an interest bearing account until such time as these monies are turned over to the County Treasurer or designee.

Exceptions to Interest Bearing Account Requirements:

The following types of funds are not required to be placed in Interest Bearing Accounts:

- Petty Cash and Change Funds under \$5,000.00
- 2. Cash drawn from a Federal agency under a letter of credit, which cash is to be paid out within 5 working days to a vendor.
- Amounts derived from the sale of bonds or notes, only to the extent that a specific written opinion of counsel states that the earning of (full) interest would result in the bonds or notes being classified as an arbitrage (not federally tax-exempt) issue pursuant to Federal regulations. To the extent that some interest is allowable, it shall be deposited at such a rate if such a rate is obtainable.

Treasurer's Report:

It shall be the responsibility of the County Treasurer to provide to the Board of Commissioners a Treasurer's Report on a monthly basis which shall detail the following information as required by N.J.S.A. 40A:5-14.e. as amended by P.L. 1997, c.148 on June 30, 1997:

- 1. All investments made or redeemed over the past month;
- 2. Each financial institution holding local unit funds;
- 3. The amount of securities purchased or sold, class or type of securities purchased, book value, earned income, fees incurred, and market value of all investments as of the report date and:
- 4. Other information that may be required by the Board of Commissioners or deemed appropriate by the Chief Financial Officer.

Cash Flow Analysis:

An important part of establishing the County investment program includes detailed study of "cash flow" – when money comes in, when it goes out, and how much cash lies available for how long. Such an analysis provides the information needed to plan a viable investment procedure, including the projected length of time that funds can be invested in order to take full advantage of maturity periods with the highest yields.

Analysis of cash flow will alert the Treasurer to possible rescheduling of payments that will result in extending the life of short term investments. The Treasurer's calendar, compiled by the Division of Local Government Services and the Division of Taxation is an excellent source of specific dates regarding the above information. (1)

Reconciliation of Cash Deposits:

On a monthly basis, the Chief Financial Officer or designee shall forward revenue reports to all departments and agencies of the County of Ocean who collect monies for the County detailing cash deposits made to their revenue accounts.

The individual departments and agencies are required to then reconcile the County's reports to the records maintained by the departments.

A form provided by the Chief Financial Officer will be returned by the department or agency either agreeing with the County's records, or listing any discrepancies to be researched by the Chief Financial Officer or designee.

Bank Reconciliations:

It is the policy of the County of Ocean that all bank statements be reconciled to the County's records when received or within a reasonable time thereafter.

INVESTMENT POLICY

The investment objectives of the County of Ocean, listed in order of importance from greatest to least, are as follows:

- The ability of the investment instrument to provide for the security and safety of County funds.
- Liquidity of the investment instrument necessary to provide for County operations and obligations.
- Yield or return on the investment instrument (only after the first two considerations are met).
- Investments requiring the payment of a premium should not be purchased without the written consent of the Chief Financial Officer.

Therefore, with these objectives in mind and in compliance with the allowable investments detailed in N.J.S.A. 40A:5-14 as modified by P.L. 1997, c.148, the County Chief Financial Officer will decide on the investment vehicles to be included as approved in the County's Cash Management Plan adopted by resolution by the Board of Commissioners for the County of Ocean and reflected in ATTACHMENT B.

Additionally, the County Chief Financial Officer will select approved investment vehicles to achieve the maximum rate of return while minimizing costs and fees and providing for investment portfolio diversification by spreading idle County funds among a number of these approved investments as listed in ATTACHMENT B.

Approved Investment Vehicles

Any investment instruments in which the security is not physically held by the County of Ocean shall be covered by a third party custodial agreement which shall provide for the designation of such investment in the name of the County of Ocean and prevent unauthorized use of such investments.

Any investment not purchased and redeemed directly from the issuer, government money market mutual fund, local government investment fund, or the State of New Jersey Cash Management Fund, shall be purchased and redeemed through the use of a national or State bank located within the State of New Jersey or through a broker dealer, which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967, c.93 (C.49:3-5) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

Securities which may be purchased by the County include:

- Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America. This includes instruments such as Treasury bills, notes and bonds.
- Any federal agency or instrumentality obligation authorized by Congress that matures within 397 days from the date of purchase, and has a fixed rate of interest not dependent on any index or external factors.
- Bonds, notes or other obligations of New Jersey municipalities, local authorities, including fire districts and school districts of which the County is a part.
- Any other bonds, notes or obligations with maturities not exceeding 397 days, as permitted by the Division of Investments. This includes Certificates of Deposit.
- Local government investment pools, such as New Jersey CLASS, and the New January 6, 2025 Asset and Rebate Management Program.

WHEREAS, N.J.S.A.40A:11-9 authorizes the Purchasing Agent to award contracts and administer competitive contracts and institutes a 15 percent of the bid limit quotation threshold.

THEREFORE, \mathbf{BE} IT RESOLVED, by the **BOARD OF** COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. Jennifer L. Bowens, as a Qualified Purchasing Agent is authorized to exercise the duties of a purchasing agent pursuant to N.J.S.A. 40A:11-2(30), with specified relevance to the authority, responsibility, and accountability of the purchasing activity of the contracting unit.
- Pursuant to N.J.S.A. 40A:11-3 and N.J.A.C. 5:34-5.4, the County's bid threshold is \$44,000.
- The County Purchasing Agent is hereby authorized to purchase materials, supplies and equipment for the County of Ocean through Bids, Contracts, Window Contracts, Quotations, State Contracts and Proprietary Goods and Services in accordance with State Law.
- The County Purchasing Agent is authorized to administer competitive contracting, (40A:11-4.1 et seq).
- The County Purchasing Agent is authorized to award contracts that are in the aggregate less than 15 percent of the bid threshold without soliciting competitive quotations (40A:11-6.1).
- 6. Such purchases shall be made in accordance with the approved, annual budget of this Board.
- 7. Copies of this Resolution shall be forwarded to the County Management & Budget Department, Department of Finance and Auditor.
