## **What is the Ocean County Workforce Development Board?**

Ocean County's One Stop Career system, designed to serve job seekers, employers and students, is made possible through the Workforce Innovation and Opportunity Act of 2014. In Ocean County, policy guidance and general oversight of the One Stop System is the responsibility of the Ocean County Workforce Development Board (OCWDB). The OCWDB, which oversees programs funded through other government sources, is led by volunteer members of local businesses, educational institutions, social services agencies, organized labor, employment and training entities, faith based organizations and community organizations. The WDB's primary goal is to plan for and ensure the implementation of an effective workforce development system for Ocean County residents and businesses. The OCWDB is responsible for assessing the needs of the local workforce and developing strategies to meet those needs. Utilizing the knowledge and expertise of key industry leaders, the OCWDB members has developed strategies to meet the needs of the local workforce.

# Code Blue

During an extreme weather event, the County follows its existing Code Blue Plan.

Once a Code Blue Alert from the County Office of Emergency Management is released, information regarding the availability of weather related services, provided by non-profit and volunteer organizations, will be offered on the Ocean County Department of Human Services website, through email and via social media.

Any organization offering services mentioned herein is encouraged to contact Human Services to enhance distribution of information.

Per Code Blue legislation (NJSA A:9-43:18), Ocean County's Code Blue Plan establishes a collaborative approach to organizing existing available services during extreme cold weather for vulnerable populations in Ocean County.

This Plan institutes protocols for Code Blue Alerts, sets forth services available during Code Blue activation, and encourages all partners to communicate regarding the ongoing efforts available in the community to address the needs of individuals at risk during extreme weather events.

The Code Blue activation period is from November 1st to March 1st with the greatest risk from December to February. Risk peaks in January, the coldest month. The Plan's goal is to assist agencies in coordinating services when Code Blue alerts have been issued.

## Seniors

### Workforce 55+ /PathStone

Many Americans over age 55 want to return to the workforce, and many companies could benefit from mature, experienced employees. That's why the Senior Community Service Employment Program

(SCSEP) was created—to help make connections between older adults and employers. The Senior Community Service Employment Program (SCSEP)/ WorkForce 55+ is the only federal program targeted to help older workers obtain employment and self-sufficiency. SCSEP enables thousands of low-income seniors each year to earn and learn.

SCSEP participants gain work experience in a variety of community service activities at non-profit and public facilities, including schools, libraries, hospitals, day-care centers and senior centers.

Participants work an average of 18 hours a week and are paid minimum wage. This training serves as a bridge to employment for participants.
