The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated March 18, 2025. This amendment to the County Plan proposes County Plan deletion of the Exempt Compost Facility at the Ocean County Landfill, located on portions of Block 2, Lots 6, 14, and 20 in the Township of Manchester. The Exempt Compost Facility was originally included in the County Plan on December 2, 2013.

Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)7, the deletion of a facility which is included in the County Plan for more than two years but for which a complete permit application has not been made can be accomplished via administrative action. Therefore, the County Plan deletion of the Exempt Compost Facility at the Ocean County Landfill is hereby approved as an administrative action pursuant to <u>N.J.A.C.</u> 7:26-6.11.
