- **3. Approval of Minutes:** September 25, 2024

- 4. Program Update: 29,949.43 acres
 - Closings:
 - o Mr. Palmieri informed the Committee that there were no closing for the month of September.
- 5. Natural Lands Property Checklist
 - Mr. Palmieri informed the Committee that Ocean County Planning staff has
 developed a new property checklist for all upcoming nominations, set to be
 implemented in January 2025. This checklist will assist appraisers in determining
 the fair market value of properties and provide a more comprehensive
 understanding of each new nomination.
- 6. Old Business
 - Old Business:
 - o #745 Jake's Branch Ext., Berkeley Twp., 28.62 acres Mr. Palmieri informed the Committee that the owner has lowered their asking price from \$7,000,000 to \$3,000,000. The property owner is keen on Ocean County purchasing and preserving the land rather than having it developed. Ms. Bavais noted that this acquisition would be beneficial to Ocean County Parks & Recreation, due to it being adjacent to Jake's Branch County Park. The Advisory Committee suggested staff order consultant testing on the property, including but not limited to, mapping & environmental consulting. Mr. Agliata noted that staff will discuss the

appropriate testing to conduct and will present the findings to the Advisory Committee at its next meeting.

o #396 Berkeley Island Park Ext., 1.70 acres – Mr. Palmieri informed the Committee that the property owner has submitted a second possible offer of acquisition, which would include the entire beachfront property for \$2,850,000. Mr. Burton (Public), the property owner, stated that he would prefer to keep one lot in which he has approval to build a home that he would pass down to his family on. Mr. Burton noted that he had all appropriate permits and approvals to conduct the construction. The Advisory Committee suggested utilizing the new Natural Lands Checklist and gathering more information on the property before returning it to its next Advisory Committee meeting.

- New Applications:
 - o #753 Lighthouse Drive Mooney, Ocean Twp., 0.16 acres Mr. Palmieri informed the Committee that this next nomination is located near the Lighthouse Drive Target Area of Acquisition. The property is 0.16 acres and the owner is seeking \$18,000.00. There is currently a drainage pipe located on the property. The Advisory Committee suggested the Engineering Department purchase the parcel for mitigation purposes.
 - o #755 Cosmo's Inholding, Berkeley Twp., 1.25 acres This property located in Berkeley Township is an inholding located between the former Blackbeard's Cave and Florence T. Allen Ext. II Berkeley Twp. Donation. The owner is seeking \$125,000.00. The Advisory Committee authorized a site inspection on the property.
