February 19, 2025

WHEREAS, as the 19th century reached its midpoint, the residents of Monmouth County living south of the Manasquan River joined together to protest the lack of county money for roads, bridges and other services; and

WHEREAS, Joel Haywood, of West Creek, took the battle to the Statehouse, where on February 15, 1850, Governor Daniel Haines signed the bill creating Ocean County and setting its borders as the Manasquan River in the north to the southern tip of Long Beach Island in the south; and

WHEREAS, initially the fledgling county included six townships: Jackson, Plumsted, Dover, Stafford, Union (Barnegat) and Brick, with each having 2 Representatives on the Ocean County Board of Chosen Freeholders; and

WHEREAS, for the past 175 years Ocean County has continued to grow and flourish as one of the premier places in the nation to live, work, raise a family and retire; and

WHEREAS, Ocean County's growth skyrocketed following the opening of the Garden State Parkway in 1954 from about 50,000 residents to more than 650,000 people living in 33 municipalities today; and

WHEREAS, our towns are home to some of state's largest senior citizen and veterans populations; and

WHEREAS, Ocean County's 44 miles of white sandy beaches, pristine Pinelands and the Barnegat Bay continue to attract visitors from around the globe; and

NOW, THEREFORE, I, JOHN P. KELLY, DIRECTOR of the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, on behalf of this Board, recognizes the year 2025 as the 175th Anniversary of the Founding of Ocean County and the many community leaders, volunteers and residents who have contributed to the growth and success of Ocean County.

RESOLUTION February 19, 2025

WHEREAS, the voters of Ocean County authorized the Ocean County Natural Lands Trust Fund to provide funds for the acquisition and preservation of natural lands, open spaces and farmland; and

WHEREAS, the Ocean County Natural Lands Trust Fund Advisory Committee was established by the Board of Commissioners to review nominations to the program and forward recommendations for acquisition to the Board of Commissioners; and

WHEREAS, the Natural Lands Trust Fund Advisory Committee has received a nomination for the acquisition of property identified as Block 1213, Lots 24, 24.01, 25, 26 and 27 in the Township of Berkeley totaling approximately 0.20 acres located on Good Luck Drive; and

WHEREAS, one (1) professional appraisal was authorized to determine the fair market value; and

WHEREAS, the Natural Lands Trust Fund Advisory Committee has determined the property's attributes are consistent with the Ocean County Open Space Plan and Recreation Inventory; and ł

WHEREAS, the County of Ocean would acquire the property for a purchase price not to exceed \$810,000.00; and

WHEREAS, a public hearing on the proposed acquisition was conducted by the Board of Commissioners on February 15, 2025 as required by PL 1997, c24.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- It accepts the recommendation of the Ocean County Natural Lands Trust Fund Advisory Committee to acquire property identified as Block 1213, Lots 24, 24.01, 25, 26 and 27 in the Township of Berkeley totaling approximately 0.20 acres located on Good Luck Drive.
- It authorizes the expenditure for an acquisition price not to exceed \$810,000.00 plus up to \$3,000.00 for property tax adjustments as necessary from the Ocean County Natural Lands Trust Fund, Account Number 225-155-0151.

BE IT FURTHER RESOLVED THAT:

- 1. The proper officers of the Board are authorized and directed to sign all necessary documents in order to effectuate these purchases.
- 2. The purchase of the property is to be contingent upon the County's acquisition by purchase, deed or gift of the necessary rights-of-way along any County roads bordering the property as determined by the County Engineer.

- 3. The offices of Ocean County Counsel and County Administrative staff are hereby authorized to take all actions necessary to consummate this transaction and have the fully executed Deeds or Easements recorded in the County Clerk's Office.
- 4. The Township of Berkeley has supported acquisition of this property by Resolution No. 25-72 -R.
- 5. Copies of this Resolution shall be made available to the Ocean County Administrator, Planning Department, Finance Department, County Auditor; County Counsel; County Natural Lands Trust Fund Advisory Committee; the Township of Berkeley; and the landowner.


