After YOUR selection has been made, press the RED CAST VOTE BUTTON located in the lower right corner. This electronically records your vote.

PROPOSAL

The Board of Education of the Borough of Bay Head in the County of Ocean, New Jersey is authorized (a) to undertake various improvements, renovations, and a building addition to the Bay Head Elementary School, including the acquisition and installation of equipment, furniture and any necessary site work; (b) to appropriate \$4,291,310 for such improvements funded, in part, by a donation from the Bay Head School Foundation in the amount of \$470,430, “Hurricane Sandy” insurance recovery funds in the amount of \$247,930, and funds transferred from the School District’s capital reserve account in the amount of \$272,950; (c) to issue bonds of the School District in the principal amount of \$3,300,000; and (d) to transfer funds between the school facilities projects.

The final eligible costs for the proposed improvements approved by the New Jersey Commissioner of Education are \$1,903,286. The proposed improvements include \$96,811 for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State’s debt service aid percentage will equal 40% of the annual debt service due on the final eligible costs of the project.

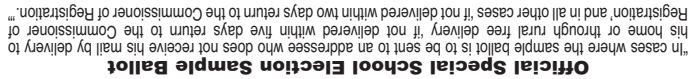
